# **General Description:**

Serve as the associate teacher in a site program with more than 30 students; plan and supervise activities to meet the needs and interests of children, utilizing knowledge of school age child development.

## Distinguishing Characteristics:

Incumbents at the Instructional Assistant II-Child Care level are required to have twelve (12) early childhood education (ECE) units and more years of experience and may serve as an associate teacher in a classroom with more than 30 students. In addition, incumbents at the Instructional Assistant II-Child Care level plan and implement curriculum. The Instruction Assistant I-Child Care is the entry-level in the series. Positions at this level are distinguished from the journey-level Instruction Assistant II-Child Care in that more routine functions are performed with less independence. Assignments are generally limited in scope and are set within procedural frameworks established by higher-level positions. Incumbents are required to have six (6) early childhood education (ECE) units.

## **Essential Duties and Responsibilities:**

- Plan and implement curriculum for students in a school age child development program that supports the school program and addresses various areas of childhood development, including social, emotional, physical, and cognitive domains; create a weekly written curriculum plan that is accessible to parents and supervisors; provide assistance to student based on their individual needs.
- Develop student awareness and participation in caring for the environment; facilitate opportunities for real-life activities that support the acquisition of self-help skills.
- Maintain learning environment in a safe, orderly, and clean manner.
- Observe and control behavior of children in the classroom according to approved procedures; monitor children during outdoor activities.
- Assure student understanding of classroom rules and procedures; assist students by answering questions, providing proper examples, emotional support, friendly attitude, and general guidance.

Paraprofessional II-Child Care

- Prepare and maintain records and reports related to assigned activities; ensure sign-in sheets are completed; complete injury/accident reports and behavior reports as needed; communicate incidents regarding injuries or behavior to staff and families according to established procedures.
- Assist in the development and improvement of the before and after school program; respond to family requests and communicate to all appropriate staff; use referral procedures to help families identify and independently use community, state, and federal resources; contribute to the program evaluation.
- Understand and implement basic health and safety practices in the classroom, including the handling of illnesses; administer first aid/CPR as necessary.
- Attend and participate in meetings and professional growth opportunities.
- Operate office and classroom equipment included a computer and assigned software.
- Perform other duties as required, related to the primary job duties of the assigned position.
