While we are gathering needed information, CDE is commenting on our current practices and making recommendations to address any deficiencies they note. As they continue to address issues, they will provide us a report of findings that will allow us another 45 days to make any needed changes. The process has been eye opening for not only Educational Services but for TCUSD as a whole. What has become apparent is that we will have findings that will need to be addressed in all areas of review. What we are encountering is issues with systems and processes that range back at least 5 years if not longer with very few issues truly being addressed prior to my team stepping in in August. As we come out of the process and know where we are, I want to thank my team with a special thanks to Scott for all they have done to address some historical issues.

LCAP

We are in the initial process of the 23-24 LCAP. Our first LCAP parent meeting will be held at the beginning of March with a presentation on LCAP basics. More information to follow as we begin the process of review, evaluation, and goal setting. Each school site has submitted a parent representative who will serve on the LCAP Parent Committee to help guide the process of review, evaluation, and goal setting.

Thanked the Federal Program Monitoring (FPM) team, the educational team took on FPM although it is not specifically an educational services focus, it hits every department within the district. Appreciates Amy, Scott, Chris, Cary, Irene, and Geoff for the work that they're putting into it because they are taking the lead on this and feel like they have ownership of it. This is a district function and so as we fix the findings it will be a district effort to fix those findings. Looking at ways that we can improve transparency in the district, and we have had conversations and it is about making sure that this is not a top-down decision driven district. We need the input from individuals who our decisions affect, so I had a conversation with Andy yesterday regarding some technology changes that are going to have to take place within the district but we will need to form a committee and have every site represented, we need to have staff, and we need to have our union leadership there so that when the decisions are made they are made by the people who are going to be affected by them. We will also be forming a Superintendent's Advisory Group which I will ask our Union leadership to be part and the main focus or reason for this is because I don't want budget to be something that we only talk about at the time of negotiations, we should be talking about budget the entire year because we present budget four or five times a year and so I want to make sure that you guys are all part of that process as well. We will also include something in regard to safety as well and form a committee on safety too because those impacts all of us. Speaking of safety, I attended the special meeting of the City Council today in which the sheriffs gave their report on what's going on in the city. Thanked our city partners for always thinking about the district. There was a conversation by Mayor Sternquist and council members in the direction of how we can improve the safety of schools and a school resource officer came up. This is something that we'll continue to talk about but more as a solution-oriented process. The mayor had already talked to Anthony Portantino's office and has reached out to Supervisor Barger's office about how they can help fund it so that it is a joint effort and no one municipality is really taking the brunt of the cost.
