General Description:

Assist a certificated teacher in reinforcing instruction related to physical education (P.E.) and recreational activities; provides supervision and direction to a group of students engaged in physical education activities; assist students in developing the skills necessary to successfully participate in a variety of age appropriate games and sports; maintain records of student participation and performance for the purpose of assessment; assist in the preparation of instructional materials and provide routine clerical support.

Essential Duties and Responsibilities:

- Assist a certificated teacher in reinforcing instruction to individual or small groups of students in a classroom or outdoor physical education environment; assist in the preparation of instructional materials and implementation of lesson plans.
- Provide supervision and direction to students during the P.E. period; observe and control student behavior during classroom and outdoor activities under the direction of the teacher and according to approved procedures; report cases of unusual behavior or social problems to the classroom teacher.
- Instruct students on the rules and skills of games or activities.
- Supervise, referee, or officiate sports and games where no instructional activities are required.
- Direct games, activities, and the use of P.E. equipment.
- Assure student understanding of classroom rules and procedures; assist students by answering questions, providing proper examples, emotional support, friendly attitude, and general guidance.
- Perform a variety of clerical duties in support of classroom activities such as preparing, typing, duplicating, and filing instructional materials; administer student tests and assignments; maintain student records and files as assigned.
- Consult with the teacher and site supervisor to make suggestions for programmatic changes.
- Maintain inventory of P.E. equipment and check for damaged or unsafe equipment; set-up P.E. equipment; check equipment in and out.
- Assist in the scoring of examinations and/or state physical fitness tests.

- Operate a variety of classroom and office equipment, including a computer and assigned software.
- Assure the health and safety of students by following established practices and procedures; observe students for the purpose of monitoring their safety and prevent students from engaging in unsafe activities; maintain learning environments in a safe, orderly, attractive, and clean manner.
- Administer first aid/CPR, as necessary.
- Attend meetings and in-services as assigned.
- Perform other duties as required, related to the primary job duties of the assigned position.

- Rules of traditional sports and games played at the elementary school level.
- Developmental milestones of school age children in both the physical and social domains.
- Physical education and related activities.
- Safe practices in physical education activities.
- Basic sports, exercises, and other physical activities of a school physical education program.
- Child guidance principles and practices.
- Student behavior and developmental characteristics.
- Operation of athletic equipment.
- First aid/CPR procedures.
- Basic instructional methods and techniques.
- Correct English usage, grammar, spelling, punctuation, and vocabulary.
- Oral and written communication skills.
- Basic record-keeping techniques.
- Interpersonal skills using tact, patience, and courtesy.

Ability to:

- Assist a certificated teacher in reinforcing instruction related to programs involving physical education and recreational activities.
- Perform physical education activities and exercises with students.
- Control and motivate students.
- Perform a variety of clerical duties in support of classroom activities.
- Assist in the preparation of instructional materials and implementation of lesson plans.
- Understand and follow oral and written directions.
- Communicate effectively both orally and in writing.
- Monitor, observe, and report student behavior and progress according to approved policies and procedures.
- Observe health and safety regulations.
- Administer first aid/CPR as necessary.
- Maintain records and files.
- Maintain confidentiality of sensitive or privileged information.
- Establish and maintain cooperative and effective working relationships with others.
- Operate a computer and assigned software.

Experience: Some experience working with children in an educational or learning environment.
