#### **General Description:**

Serve as the district point of contact in the area of irrigation technology and work in collaboration with the district grounds crew and maintenance personnel; troubleshoot irrigation problems; repair existing systems; design and install new systems; work from plans and prints and document system changes; serve as lead staff responsible for equipment and repairs; coordinate watering schedules with sports activities, special events, and periods of rain.

#### **Essential Duties and Responsibilities:**

- Maintain the irrigation systems for district school sites and facilities in a safe, good working condition; troubleshoot irrigation problems; repair existing systems; design and install new sprinkler systems; work from plans and prints and document system changes.
- Inspect irrigation equipment for proper adjustment, damage, needed repairs, and safety issues; determine proper pipe and valve sizing; perform low-voltage wiring for valves and controllers; rebuild valves and sprinklers.
- Coordinate watering schedules with sports activities, special events, and periods of rain.
- Assist grounds crew or maintenance personnel in work projects by performing semi-skilled labor.
- Prepare and maintain records and reports related to assigned activities; update site plans and drawings to reflect changes.
- Inventory irrigation equipment and supplies; submit purchase requisitions as needed in consultation with supervisor; estimate the quantity and types of materials or supplies needed for a work project; determine the most cost-effective means of for projects.
- Operate a variety of hand and power tools and heavy equipment related to irrigation.
- Operate a computer and assigned software; drive a vehicle to conduct work.
- Perform other duties as required, related to the primary job duties of the assigned position.

## **Required Qualifications:**

#### **Knowledge of:**

- Procedures, methods, techniques, materials, supplies, tools and equipment used in the installation, repair and maintenance of sprinkler and irrigation systems and related parts, components and equipment.
- State and federal requirements relating to health and safety of facilities.
- Safety practices for storage and use of chemicals and equipment.
- Building codes and other restrictions pertaining to sprinkler irrigation systems.
- District policies and practices for requisitioning/purchasing materials.
- Proper operation of a variety of hand and power tools and heavy equipment related to the irrigation field.
- Appropriate pipe sizes and maximum and minimum water pressure guidelines.
- Principles, practices, and maintenance of electronic controllers used in irrigation systems.
- Oral and written communication skills.
- Basic record-keeping techniques.
- Basic math calculations.
- Interpersonal skills using tact, patience, and courtesy.

## Ability to:

- Perform a variety of skilled activities involved in the layout, installation, maintenance and repair
  of District sprinkler and irrigation systems and related parts, components and equipment.
- Interpret and work from blueprints, plans, schematic drawings, and sketches.
- Troubleshoot, diagnose and resolve irrigation system malfunctions.
- Work independently and follow through on assignments with minimal direction.
- Use power tools and equipment used in irrigation.
- Test and repair water leaks.
- Make calculations using basic math functions.
- Prepare and maintain accurate records.
- Understand and carry out oral and written instructions.
- Develop schedules and maintain records.
- Operate a computer and assigned software.
- Plan, prioritize and organize work.
- Meet schedules and timelines.
- Communicate effectively both orally and in writing.
- Establish and maintain cooperative and effective working relationships with others.
