On motion of Member Goold, seconded by Member Huff, and on a 4-0-1 roll call vote (Aye: Goold, Huff, Knollenberg, Marston; Nay: None; Abstain: Bell), the Board adopted Resolution 1718-16 to Waive Credential Requirements for the Acting Superintendent Pursuant to Education Code section 35029.

Adoption of Resolution 1718-16 to Waive Credential Requirements for the Acting Minutes of the Special Meeting of the Temple City Unified School District Board of Education of May 21, 2018

On May 9, 2018, the Governing Board appointed Chief Business Official Marianne Sarrail as Acting Superintendent of the Temple City Unified School District. The appointment became effective on May 10, 2018, the first business day following the appointment. Ms. Sarrail is not required to possess a credential when serving as Chief Business Official. During the time she serves as Acting Superintendent, she must either possess a credential as required by Education Code section 35028 or have the credential requirement waived by the Governing Board pursuant to Education Code section 35029.

Superintendent Pursuant to Education Code section 35029

This Resolution will waive the requirement of Education Code section 35028 during Ms. Sarrail's service as Acting Superintendent.

The Board had a discussion about Agenda item #6, acknowledging that they will be discussing appointing someone with the appropriate credentials, and if the resolution was necessary. The Board discussed reasons why it was necessary to appoint Ms. Sarrail at this time. The resolution is a necessary procedure to make the appointment and providing a waiver after the appointment is routine. Mr. Kinsler explained that according to Ed. Code, this is permissive and not obligatory but a good step for the District to take.

On motion of Member Marston, seconded by Member Goold, and on a 5-0 vote, (Aye: Bell, Goold, Huff, Knollenberg, Marston) the Board adjourned to Closed Session at 8:48 a.m.
